6 WHEREAS the Christ United Methodist Church (“Christ UMC”) located in the City of Alsip, Illinois at  
7 the commonly known address 3730 W. 119<sup>th</sup> Street in Rich Township of Cook County, Illinois was formed  
8 and has witnessed to Jesus Christ and served its community and the world for many years and having  
9 closed on July 20, 2025, and

10 WHEREAS Christ UMC faithfully served the community in the City of Alsip, IL, and boldly risked  
11 themselves in this effort; and

12 WHEREAS, pursuant to the provision of Paragraph 2549 of *The Book of Discipline of The United*  
13 *Methodist Church 2020/2024*, the Lake South District Superintendent has recommended with the approval  
14 of the District Strategy Team that the church be discontinued effective July 20, 2025. The Lake South  
15 District Committee on Building and Location has voted to concur with the District Superintendent’s  
16 recommendation to discontinue said church and the presiding Bishop and the majority of the District  
17 Superintendents of the Northern Illinois Annual Conference of The United Methodist Church have  
18 consented to the District Superintendent’s recommendation to discontinue said church;

41 The United Methodist Church are authorized and directed to execute on behalf of the said Conference any  
42 and all such additional documents as legal counsel shall recommend to effectuate the above.

43 **RATIONALE:**

44 After many faithful years of service, ministry and mission in the name of Jesus Christ, Christ United  
45 Methodist Church of Alsip has come to a place of transition and closure as membership and attendance  
46 have declined. The congregation has expressed its desire to celebrate its past ministry but to no longer  
47 remain in service as Christ United Methodist Church. The closure has been recommended by the Lake  
48 South Board on Church Location and Buildings and the District Superintendent.

7 Church”) located in the City of NAPERVILLE Illinois at the commonly known address 1852 95th Street  
8 Naperville, IL 60564, in Naperville Township of Will County, IL was formed and has witnessed to Jesus  
9 Christ and served its community and the world for many years and having closed on December 31, 2025,  
10 and

11 WHEREAS the Church faithfully served the community in the City of Naperville, IL, and

12 WHEREAS, pursuant to Paragraph 2549.4(b) (Ad Interim procedures) of *The Book of Discipline of The*  
13 *United Methodist Church 2020/2024*, the Prairie Central District Superintendent recommended that the  
14 church be closed due to exigent circumstances, namely, the inability to sustain operations due to a lack of  
15 funds.

16 WHEREAS, the presiding Bishop and the majority of the District Superintendents of the Northern Illinois  
17 Annual Conference of The United Methodist Church (“the Conference”) consented to the District  
18 Superintendent’s recommendation to discontinue the Church, effective December 31, 2025.

19 WHEREAS, the Prairie Central District Committee on Building and Location voted to concur with the  
20 District Superintendent’s recommendation to discontinue said church.

21 WHEREAS, church discontinued regular operations effective December 31, 2025.

22 THEREFORE BE IT RESOLVED that the Annual Conference hereby affirms that the Church discontinue  
23 operations.

24 BE FURTHER RESOLVED that all properties and assets of said Church, including, but not limited to  
25 its existing and future gifts, devises, and bequests, its existing personal property and accounts and its  
26 real property commonly known as 1852 95th Street Naperville, IL 60564, title of which has vested in the  
27 Conference through the Board of Trustees of the Conference pursuant to Paragraph 2549.4(b) shall remain  
28 the properties and assets of the Northern Illinois Conference of The United Methodist Church subject to  
29 the 2020/2024 Book of *Discipline*, and the By-Laws of the Northern Illinois Conference.

30 BE IT FURTHER RESOLVED that, to minimize the risk of loss of future bequests to the Conference and  
31 protect the integrity and ownership of the property of the church held in trust for the denomination, the  
32 Northern Illinois Annual Conference recommends that the said Church, though discontinued under the  
33 Canon Law of The United Methodist Church, nevertheless be maintained in perpetuity under the Illinois  
34 civil law by adopting a reincorporation thereof by the Bishop under Section 46b of the Illinois Religious  
35 Corporation Act, with the incumbent Conference Board of Trustees named as trustees of the Discontinued  
36 Church under the procedure established by Article VII “Discontinued or Abandoned Church

38 Church and that the Conference take whatever action is necessary to protect the integrity and ownership  
39 of all property including any existing or future bequests held in trust for the benefit of the denomination;

42 Grace UMC unless any such members shall inform the pastor of the transferee church otherwise; and

46 **RATIONALE:**

47 After many faithful years of service, ministry and mission in the name of Jesus Christ, Naperville:  
48 Wheatland Salem United Methodist Church has come to a place of transition and closure. Membership  
49 and financial sustainability have been declining for many years. The decline reached the point where  
50 foreclosure of the real property was being raised by the holder of a large mortgage on the property, namely,  
51 Red Door. To protect the Conference's ability to preserve the property, closure under Paragraph 2459.4(b)  
52 became necessary subject to approval at the next Annual Conference.

9 2) Local churches are to provide a minimum of \$2,500\* for accountable reimbursements for their  
 10 appointed Elder(s). This covers the costs of providing travel, continuing education, and other  
 11 expenses incurred in the course of providing pastoral ministry. Information about accountable

13 *\*Ideally the church maintains \$5,500 but, in an effort to maintain full-time, some churches may need*  
 14 *to reduce the reimbursement to \$2,500. Anything lower will not allow the pastor to engage in fruitful*  
 15 *ministry.*

16 **RECOMMENDATIONS:**

- 17 • The Equitable Compensation Task Force (ECTF) recommended a minimum salary for fulltime  
 18 Elders to be approximately \$50,000 by 2026 for FY 2027, achieved by 7.0% increases during the  
 19 years (2025, 2026, and 2027). However, the **Equitable Compensation Committee** (formed in  
 20 2024) is recommending an increase of 2.8% for 2027 to \$47,976 based on the following:
  - 21 ▪ A third consecutive increase of 7% per year would be a hardship for many churches as  
 22 other costs have also or will also increase in 2027.
  - 23 ▪ Healthflex rates will increase in 2027, however, those rates will not be finalized until after  
 24 legislation has been published.
  - 25 ▪ An increase in base salary will raise the cost of retirement benefits to churches.
  - 26 ▪ Property and Liability insurance rates will most likely increase as well.
- 27 • The United Methodist Book of Discipline does not require Annual Conferences to establish a  
 28 minimum salary for LLPs. However, to responsibly recognize changes in buying power, the  
 29 Equitable Compensation Committee recommends that the minimum salary for Licensed Local  
 30 Pastors be the same as the Elder increase of 2.8%. This brings the salaries more in line with each  
 31 other.

32 **RATIONALE AND METHODOLOGY:**

- 33 • In 2023, an Equitable Compensation Task Force (ECTF) was formed, the current Equitable  
34 Compensation Committee (formed in 2024) has included their rationale from 2023 below. In  
35 reviewing all the factors, the bold information is what drove the decision to reduce the increase  
36 for FY 2027.

- 37 ▪ The ECTF submitted surveys to all US Annual Conferences and received 18 replies. The  
38 NIC is currently second to last in minimum salary (by a sliver margin of \$165) among the  
39 18 annual conferences responding to the survey. Had the 2023 Annual Conference not  
40 approved of the 8.7% increase, bringing the current minimum to \$40,763, NIC would be  
41 at the bottom. Current minimums across annual conferences range from \$40,598 to  
42 \$50,923.

- 43 • **The Equitable Compensation Committee (ECC) is also aware and recognizes**  
44 **that increasing the minimum salary may be a financial burden that some**  
45 **churches cannot bear. As we move forward, fewer single-charge full-time**  
46 **appointments will most likely be the new normal.** The ECC is committed to  
47 continuing to monitor the trends and work with the Cabinet and churches on  
48 ways to equitably compensate clergy.

- 49 ▪ The ECTF determined that their recommendation would be focused on base  
50 compensation only, having found it impossible to identify/consider values of parsonages,  
51 housing allowances, or health insurance benefits due to the wide disparities between  
52 conferences and the extreme difficulties in assigning dollar values.

- 53 ▪ This survey showed that a lower minimum salary for LLPs is consistent with the other  
54 annual conferences responding to the survey.

- 55 ▪ The UMBoD ¶342 speaks only to “*Elders in full connection*” who assume “*the*  
56 *obligations of the itinerant ministry*” and who bear the burden of extensive student loans  
57 from the required master’s degree. Further, “*the Church shall provide, and the ordained*  
58 *minister is entitled to receive, not less than the equitable compensation established by the*  
59 *annual conference for clergy members.*”

- 60 ▪ The UMBoD states in ¶625.2(a) that the Equitable Compensation Commission be  
61 responsible for “*recommending conference standards*” for pastoral salaries, and (b)  
62 “*administering funds to be used in base compensation supplementation.*”

5 **ACTION:**

- 6 1. We, the people and churches of the Northern Illinois Conference of The United Methodist  
7 Church, confess our failure to properly steward God’s earth;
- 8 2. Prayerfully ask for God’s help in restoring Creation;
- 9 3. Join our Bishops, denominational Boards and Commissions in committing to net-zero greenhouse  
10 gas emissions by 2050; and
- 11 4. Encourage every local church to host a “Creation Care Worship Service” on the Sunday before or  
12 after Earth Day (April 22) to remind us through word and deed that we are bound to each other  
13 cellularly and socially, holding and being held in the web of relations, honoring each species  
14 extinction as a death of divinity. In conjunction with the green service, there will be a creation  
15 care study.

16 **RATIONALE:**

17 In November 2025, the Council of Bishops reaffirmed the biblical call to care for creation, recalling  
18 God’s covenant with Noah in Genesis 9:16. In this covenant, God promises no harm to humanity or  
19 creation, and we, as followers of God, are likewise called to do no harm and to care for all that God has  
20 made. This covenantal relationship compels us to act as faithful stewards, protecting the health and  
21 goodness of the earth and resisting harm caused by greed, neglect, or inattention. Building on prior  
22 statements, the Council emphasizes that now is a critical time to renew our commitment to creation care.

23 The urgency of this moment is clear. In 2024, global temperatures rose to an average of 1.55°C,  
24 exceeding the 1.5°C threshold identified in the 2015 Paris Agreement. Scientific reporting has linked  
25 rising temperatures to increased mortality, pollution, wildfires, and the spread of disease. While developed  
26 nations bear the greatest responsibility, the most severe impacts fall on those who contributed least—  
27 developing countries, communities of color, economically vulnerable populations, children, and future  
28 generations. We can no longer ignore our covenantal responsibility to care for creation and one another.

29 The Social Principles of The United Methodist Church affirm this urgency, acknowledging that  
30 unsustainable human activity has placed all creation in peril. They name climate change, ecosystem  
31 destruction, fossil fuel dependence, environmental racism, food injustice, and environmental toxins, and  
32 call us to adopt sustainable and just practices as an expression of faithful stewardship.

33 The 2024 General Conference further calls the Church to action. We committed to organizing at least one  
34 church-wide creation care initiative annually and to engaging in ongoing study for deeper understanding  
35 of creation care and justice.

36 This resolution encourages congregations to respond through faithful, practical action in four key areas:

37 **Worshipping:** incorporating weekly prayers for creation; observing Earth Day; hosting prayer vigils;  
38 offering outdoor worship; developing creation-focused liturgy; and sharing testimonies connecting faith  
39 and care for the earth.

40 **Educating:** offering Bible studies and programs on creation care; hosting discussions or films; engaging  
41 children and adults in nature experiences; inviting speakers on local environmental issues; fostering cross-  
42 cultural learning about environmental justice; and utilizing denominational resources and training  
43 opportunities.

44 **Practicing:** reducing waste and eliminating single-use plastics; conserving water and energy; exploring  
45 renewable energy sources; creating gardens, green spaces, and pollinator habitats; recycling and  
46 composting; improving building efficiency; and engaging in community-based environmental efforts such  
47 as clean-up projects or shared gardens.

48 **Speaking Up:** encouraging congregational awareness of environmental issues; communicating with  
49 decision-makers; organizing advocacy efforts; collaborating with other churches and community partners;  
50 and integrating sustainability into church planning and decision-making.

51 Through these actions, congregations embody their covenant with God and participate in the healing and  
52 restoration of creation. This work is essential to our identity as people of faith, called not only to do no  
53 harm, but to actively seek the flourishing of all creation.

7 Committee on Nominations. Section III B as follows:

8 **B. NOMINATIONS PROCEDURE**

- 9 1. The nominations process is an open process. Persons can be nominated from any source within the  
10 Conference. All nominees for membership on conference agencies shall be presented to the Annual  
11 Conference by the Committee on Nominations except members-at-large of conference agencies and  
12 those otherwise directed by The Discipline or the Standing Rules. Suggestions of persons particularly  
13 qualified for such membership may come to the Committee on Nominations from any agency.
- 14 2. Elections at Annual Conference will take place in the following manner: A full slate will be  
15 presented with ~~containing only~~ the names of those to be elected at the current session of Annual  
16 Conference in bold. ~~will be presented. Those who have been serving during the past year will be~~  
17 ~~designated from those most recently nominated. Persons whose Additional names do not appear on~~  
18 ~~the slate~~ may be offered from the floor in accordance with conference nominations procedures  
19 subject to the deadline established by the Committee on Nominations for each year's regular session  
20 of annual conference. Any additional names offered in nomination for any position to fill a blank  
21 space or in substitution for an existing name will need the following information:  
22 a. Position for which person is being nominated  
23 b. Full name, correctly spelled  
24 c. Complete address, home and work phones, if available  
25 d. Personal data  
26 e. Local church affiliation  
27 f. Tenure in previous service to this group  
28 g. Name of person making nominations  
29 h. Consent of nominee to serve
- 30 The Committee on Nominations will reconcile Disciplinary and Standing Rules requirements.
- 31 3. Except as otherwise directed by The Discipline, when a vacancy occurs in any Conference group:  
32 a. Notification of a vacancy will be made to the Conference Committee on Nominations.  
33 b. The Conference Committee on Nominations shall fill the vacancies within 60 days of

8 **Shepherding Teams (“NIC”) (§ 608)**

9 **Role of the ACST**

10 The Annual Conference Shepherding Team was created to advance the overall mission of the Northern  
11 Illinois Conference by ensuring the proper use and alignment of resources to achieve it. The ACST serves  
12 as a place for consultation, advice, and decision-making, and provides connections between conference  
13 administrative and ministry areas, the cabinet, District Shepherding Teams, and local churches. It serves  
14 to build trust, collaboration, and accountability in the conference’s responsibility to live out its mission.  
15 Specifically, the ACST is:

- 16 - A council of advisers to the bishop and conference leadership
- 17 - A decision-making body between annual conference sessions and for those items not requiring  
18 conference action
- 19 - A contributor to the overall budgeting process with final review prior to annual conference  
20 session
- 21 - The oversight body for the District Shepherding Teams in collaboration with the district  
22 superintendents
- 23 - An adaptive learning organization that provides insights and teaching about effective leadership  
24 in the 21st century church

25 **I. Overview**

26 The organizational structure shall be centered on an Annual Conference Shepherding Team (“ACST”).  
27 There shall be a separate District Shepherding Team (DST) in each of the districts. Both Co-Chairs of  
28 each DST (6 members in total) shall also serve as members of the ACST as outlined below. The ACST  
29 shall be an adaptive learning organization whose primary purposes shall be to coordinate and  
30 communicate the ministry of the NIC for the sake of making disciples for Jesus Christ. The primary  
31 purposes of each DST shall be to coordinate the equipping of local churches so that they might be  
32 faithful, Christ-centered communities of worship, prayer, witness and change, and to enhance the  
33 connection between local churches, the districts and the NIC.

34 **II. Annual Conference Shepherding Team (“ACST”)**

- 35 **a. Responsibilities.** The responsibilities of the ACST shall include,
  - 36 i. Leading as a learning organization in addressing the technical and adaptive, challenges and  
37 opportunities presented to the NIC.
  - 38 ii. Providing coordination of the ministry, mission, and vision of the NIC.
  - 39 iii. Discerning a 5-year vision plan; presenting it for approval by NIC; communicating it  
40 throughout the NIC, monitoring and adapting it on an annual basis.
  - 41 iv. Focusing NIC resources to equip local churches and ministry settings to make disciples of Jesus  
42 Christ for the transformation of the world.
  - 43 v. Facilitating communication and healthy relationships between districts, NIC leadership, staff,  
44 committees, and ministries.
  - 45 vi. Advocating, monitoring, and celebrating diversity at every level of leadership throughout the  
46 NIC.
  - 47 vii. ~~Stewarding financial and leadership resources for maximum missional impact. The role of the~~  
48 ~~ACST in the budgeting process shall be to augment the existing process in which the budget is~~

49 prepared by the Conference Council on Finance and Administration (“CCFA”) and approved by  
50 the NIC. The ACST shall consult with CCFA in the allocation of resources according to the  
51 ~~missional program~~ priorities of the NIC. Communicate and collaborate with CCFA toward  
52 alignment of financial resources with priorities and vision. At each meeting of ACST, the CCFA  
53 designate shall make a presentation regarding the financial position of NIC, including but not  
54 limited to the budget. ACST may make recommendations to CCFA regarding the annual budget of  
55 the NIC.

56 viii. Resolving leadership and function questions that do not require approval by the NIC between  
57 annual conference sessions.

58 ix. Guiding the NIC in the event of a significant shift in the denomination or jurisdictional  
59 realignment of conferences.

60 x. Adapting the organizational structure further to align with the missional priorities of the NIC.

61 xi. Developing clear and concise qualitative and quantitative metrics to evaluate the effectiveness  
62 of ACST structure and work.

63 xii. Reporting annually to NIC on fulfillment of the above responsibilities.

64 **b. Core Areas of focus.** The ACST shall prayerfully focus on the following Core Areas of priority  
65 identified in the Landscape process:

66 I. Congregational Life

67 1. Creating and revitalizing congregational cultures that are deep in faith and engaged for  
68 evangelism.

371 **RATIONALE:**

372 The 2008 United Methodist Book of Discipline created flexibility for annual conference organization.  
 373 Conferences were encouraged to streamline structures to create relevant, vital program ministries. In  
 374 2018, the Annual Conference approved the incorporation of the ACST and DST, and in 2020, the ACST  
 375 formed a task force to reorganize the conference's program areas. This task force reviewed the program  
 376 ministries and recommended the retention of some areas, the consolidation of others, and the  
 377 incorporation of areas that had become inactive or had a focus addressed by other existing boards,  
 378 committees, and task forces. They then organized these committees, boards, task forces, and groups in  
 379 alignment with the purpose, mission and core values of the annual conference.  
 380

381 In 2024, ACST developed and began implementing a new role that has helped to understand the purpose  
 382 of this group which is included in this document, and now it is an appropriate time to update certain areas,  
 383 delete inactive group or committees and reduce redundancy. Making these adjustments ensures that the  
 384 structure reflects the realities of the ACST's current work while strengthening its sustainability and clarity  
 385 for the years to come.

6 In the Standing Rules, Section V Finances and Reports, A. Accounting Policy, 11, amend as follows:

7 When local church buildings become the property of the Annual Conference and the properties are to be  
8 sold in accordance with Disciplinary procedures, the disposition of all net assets of the local church shall  
9 be deposited in the Closed Church Fund (also known as the Congregational Development Fund). The  
10 closed local church's unpaid obligations to the annual conference, including property insurance and  
11 clergy benefit delinquencies, shall be drawn from the proceeds of sale. 1% of gross proceeds from the sale  
12 of a closed church asset is reserved to fund archive needs. 25% of the net proceeds from the sale of closed  
13 churches shall be directed to the Conference Board of Trustees to manage and maintain the properties in  
14 their care. The assets of the Closed Church Fund shall be directed by the Cabinet in consultation with the  
15 Director of Congregational Development and Redevelopment for actual expenditures on starting,  
16 developing, and redeveloping local churches in the Annual Conference. Upon recommendation of the  
17 Board of Trustees, the Annual Conference, by majority vote, may direct the proceeds to another use.

18 **RATIONALE:**

19 Currently, expenses related to selling closed churches are taken from the Closed Church Fund. Expenses  
20 related to the maintenance and property are taken from the Apportionment Funds. This legislation allows  
21 for an additional source of funding that may offset the apportionment budget, which will allow the  
22 apportionment budget for other items. For example, in the last 5 years, NIC has sold between \$325,000 to  
23 \$1.1M in closed churches, 25% would \$81,250 - \$275,000 that the Board of Trustees would have been  
24 able to use.

25 This legislation offers an alternative way to fund the maintenance of the property in our care, so that  
26 we can lower our pull on the apportionment funds given from our local churches.
