## The Fellowship of Local Pastors and Associate Members Report

## Registrar, Rev. Sharon Engert

The Fellowship of Local Pastors and Associate Members have 2 meetings per year for fellowship, learning, growth, ministry, and support.

1st. This year we had our Spring Meeting on March 30<sup>th</sup>, 2019 at Community United Methodist Church at LaMoille (great host Pastor David Jungnickel and his congregation).

Realizing that the District Superintendent Supply Pastors, for the most part, do not have a clergy collegial support system, we once again invited the DSSs to join us for our Spring meeting and a few of them attended and it seemed very well received.

We had over 20 persons in attendance. Our attendance was a bit down because of a time conflict with Conference discussions concerning General Conference 2019.

Rev. Luis Reyes was our morning speaker on the topic of General Conference 2019 and he specifically geared his talk, discussion, and handouts as to how these General Conference decisions affect Local Pastors.

Rev. Fritz Bartells was our afternoon speaker on the topic of Sacraments and he specifically geared his talk and discussion for a better understanding of the Sacraments for ourselves, for our congregations, and for going before our dCOMs. Further discussion continued concerning dCOMs, in general, and our interview process.

We then celebrated Holy Communion together.

2nd. Our 2<sup>nd</sup> meeting of the year typically has been a luncheon at our Annual Conference. However, this year, by an email vote, we have decided that a luncheon at Annual Conference is cost prohibitive. We look forward to doing something in the Fall, 2019. Wheatland-Salem UMC has graciously agreed to host this event.

On a personal note, it has been my pleasure to serve as the Registrar of The Fellowship of Local Pastors and Associate Members since 2016. I continue to

- monitor and organize Course of Study transcripts,
- monitor statistics of Local Pastors and Associate Members,
- plan 2 meetings per year,
- endorse COS registration,
- apply for COS reimbursement,

• support Local Pastors and Associate Members (and lately, also, DS Supply Pastors),

• and represent Local Pastors and Associate Members on the Board of Ordained Ministry.

This past April, I updated our Fellowship of Local Pastors informational booklet so that we can be relaying accurate information to future and current local pastors. This manual has been given to District Superintendents, to dCOM Chairs and Registrars, to each member of the Board of Ordained Ministry, and to Local Pastors, Associate Members, and District Supply Pastors.

This past September I attended the 3-day FLPAM annual meeting at GBHEM, Nashville with about 30 other Local Pastor Conference registrars and chairs within the United States UMC Conferences. I enjoyed a time of learning, fellowship, and worship with them and I learned a great deal about what other Conference Local Pastors are doing. I plan on attending the 2019 meeting this year...to be held at Ginghamsburg UMC, Tipp City, Ohio in September.
